We have a quick question for you regarding some of the data that came from the 2006 French Frigate Shoals cruise. Specifically, these are photos of crabs and other invertebrates taken by Joel Martin and Leslie Harris (both NHM staff) while on the cruise.

We're starting to use some of the images for more diverse purposes here at the Natural History Museum of Los Angeles County (notably, we're about to file some of them into a Museum-wide, and soon-to-be-public specimen database).

Now that we're beginning to "expose" the photographs a bit more, we're being pressed on what intellectual property rights apply to them. Because they were taken on a U.S. Government NOAA cruise, are they Public Domain? Or because the photos were actually taken by non-government employees, do they fall into another copyright category?

If you can let us know what the copyright status of those images is, we'd be most grateful. If you're not sure, any pointers to people who would know would be appreciated.

Regarding photo credits from the 2006 French Frigate Shoals (FFS) cruise:

When the FFS cruise took place, it was determined between the Papahanaumokuakea management co-trustees that all images and information from French Frigate Shoals are provided "courtesy of the Northwestern Hawaiian Islands Marine National Monument, Hawaiian Islands National Wildlife Refuge, the Northwestern Hawaiian Islands State Marine Refuge, and NOAA's Pacific Islands Fisheries Science Center in accordance with permit numbers NWHIMNM-2006-015, 2006-01, 2006-017, and DLNR.NWHI06R021 and associated amendments". (see <a href="https://www.creefs.org">www.creefs.org</a>, "French Frigate Shoals Census")

That said, if it is a simple photo credit, it can read: "Photo by \_\_(photographer)\_\_, courtesy of the Northwestern Hawaiian Islands Marine National Monument (or Papahanaumokuakea) co-trustees, CReefs, and NOAA Pacific Islands Fisheries Science Center, 2006".

These photos can be used for science and outreach, but are not for commercial gain...unless otherwise determined via "compatibility determination".

OK, 'fraid I'm back!

One thing that's still unclear to us is who's the actual copyright holder (if there is one, unless the materials are in the public domain).

The request for credit to the organizations is not the same as asserting that they hold legal copyright on the images. The copyright holder has the right to license usage under those (or other) terms, but who is the actual copyright holder? (The exception, of course, would be if these are considered to have been prepared by a government employee as part of their official duties, in which case they would not be subject to copyright at all.)

It looks as though the use limitations are similar to a Creative Commons "Attribution Non-Commercial" license (<a href="http://creativecommons.org/about/licenses">http://creativecommons.org/about/licenses</a>). Is that, in fact, what's being used? If not, has that licensing been considered? A big advantage to using a CC licence is that publishers, web-site designers, and other institutions are pretty familiar with how those work.

Hi Dean.

Because these photographs were taken on a government vessel, during government time, in a permit-only area (managed by government entities), they shouldn't be subject to copyright. Though, they are the property of NOAA (and therefore available for public viewing) b/c it was on a NOAA vessel, on a NOAA-led and permitted research expedition.

I am not familiar with the "CC" license, and don't really have the authority to make such a decision on NOAA photographs. It would take a huge amount of effort, going through several levels of government as well as the other institutions listed, to explore such a thing and so I don't think that is a place we will be going.

I have copied Wende Goo here, as she may have more input on the matter.

Our understanding now is that the images taken by NHM staff on the 2006 Northern Hawaiian Islands cruise are public domain, and not subject to copyright. (As a side issue, that makes it impossible to assign any licensing to them, Creative Commons or otherwise.)
